## **PURPOSE AND PHILOSOPHY**

---



### **STATEMENT OF FAITH**

We believe there is one God, eternally existent in the Persons of Father, Son, and Holy Spirit.

We believe the Bible to be the only inspired and infallible Word of God. The King James Version of the Bible shall be the official and only translation used by the school.

We believe in the virgin birth and Deity of the Lord Jesus Christ; His vicarious and atoning death through His shed blood; His bodily resurrection; His ascension to the right hand of the Father; and His personal, pre-millennial return in power and glory.

We believe that, for the salvation of sinful men, regeneration by the Holy Spirit is absolutely essential.

We believe in the resurrection of both the saved and the lost—those who are saved unto the resurrection of the pretribulation coming of Christ, and those who are lost unto the resurrection of damnation.

We believe in the spiritual unity of believers in Jesus Christ.

We believe in the present ministry of the Holy Spirit, by whose indwelling the Christian is able to live a godly life.

### **PHILOSOPHY**

The primary objective and purpose of Victory Christian Academy, as a ministry of Victory Baptist Church, is to lead our students to a saving knowledge of Jesus Christ, to educate them with a sound

Biblical worldview, and to prepare them to positively impact their families, churches, communities, and country for God.

Victory Christian Academy meets all requirements of the North Carolina Division of Non-Public Instruction and is a member of the North Carolina Christian School Association.

## **ADMISSION AND ENROLLMENT**

---

### ***ADMISSIONS POLICY***

Victory Christian Academy does not discriminate in its admittance or policies regarding a person's race, ethnicity, or national origin.

VCA welcomes students interested in a Christian education, who are found qualified for admission, and who agree and whose parents agree that the students shall abide by the rules and philosophy of the school. It must always be understood that attendance at VCA is a privilege and not a right.

Victory Christian Academy, as a private institution, reserves the right to maintain its own standards of dress and conduct. As such, students who do not adhere to the rules and philosophy of the school may be refused admittance or discontinued enrollment.

### ***REGISTRATION/ENROLLMENT FOR NEW STUDENTS***

1. Complete the application form including required documents. These forms may be completed online or dropped off at the school office.

2. After the application has been processed, a formal interview with the prospective student and parents will be scheduled.
3. Upon acceptance, the reservation fee and signed statement of cooperation will be due.

## **WITHDRAWAL**

In the event a parent wishes to withdraw their child from VCA, an official withdrawal letter must be presented to the office. If the balance is not up-to-date at the time of withdrawal, all grades and records will be held until the balance is paid. No refunds will be made for fees such as registration, books, or tuition. Withdrawals are charged tuition for any month in which they attend. Exceptions to these policies must be requested in writing explaining and providing an alternate plan for bringing the account current.

## **GENERAL INFORMATION**

---

### **AFTER-SCHOOL SUPERVISION**

Parents are asked to pick up students promptly at the time of their dismissal. Any student who remains at school fifteen minutes after scheduled dismissal times will be sent to after-school care (fee-based service).

### **ARRIVAL AND DISMISSAL**

Parents may drop off students beginning at 8:00 A.M. Parents who need to drop off before this time should make prior arrangements with the school office. A fee is charged for this service. Dismissal

time for K4 and K5 (half day) is at 11:50 A.M. Dismissal time for K5 (full day) through 12th grade is at 3:00 P.M. Parents who need to pick up their child before dismissal must go to the office.

## ***ATHLETIC PROGRAM***

The purpose of Christian athletics includes building character in the life of each athlete, exercising the ability to work with others, developing self-discipline, encouraging others to do their best, developing lasting relationships, and helping each athlete conform to the image of Jesus Christ. Students must meet academic, attendance, and conduct requirements to remain eligible for the athletic program.

- **Academic requirements:** Students must maintain a C average in each class in order to participate in practices and games. Eligibility will be evaluated on a weekly basis.
- **Attendance requirements:** Students who are not in attendance in school will not be permitted to attend practice or games.
- **Conduct requirements:** Students are to conduct themselves in a respectable Christian manner. Harassment of officials or the opposing team is not acceptable and may result in removal from the event.

## ***ATTENDANCE REQUIREMENTS***

1. For your child to succeed academically, he must be regular in attendance. The school office should be notified of planned absences, such as family vacations, in advance so that work can be assigned and completed prior to or upon returning to class. Failure to give advance notice may result in partial credit. Planned absences will count toward the total number of absences for the year.

2. Attendance for 7th–12th grades will be kept by individual class periods. Yearly attendance will be kept by half and full days. Students must be in class most of the class period to be counted present.
3. Any elementary student who arrives after 10:00 A.M. or leaves before 12:00 P.M. will be counted as absent for half of a day.
4. As a general rule, make-up work must be completed within two days of returning to school. Make-up work for long periods of absenteeism is given special consideration and is handled on an individual basis.
5. Credits for high school courses will not be awarded when a student has missed more than ten days per semester for a half credit course and twenty days for a one credit course.
6. If an elementary or middle school student is absent for more than twenty days per year, he will not be promoted to the next grade.
7. Exceptions to the attendance policy are subject to administrative approval on an individual basis.
8. The school day begins promptly at 8:30 A.M. All students are expected to be in their class at this time. Late arrivals are to report to the school office. Five late arrivals within one grading period will be counted as one day absent. This rule applies to all students. Please make every effort in ensuring students arrive at school on time.
9. Students are expected to be on time for all classes. Tardiness will result in demerits being issued for students in the 5th–12th grade. This does not apply to late arrivals.

## **AWARDS**

1. **A Honor Roll** - given each nine weeks in chapel to students who have earned all A's during a grading period
2. **A/B Honor Roll** - given each nine weeks in chapel to students who have earned all A's and B's during a grading period
3. **Perfect Attendance** - given to any student who has been present every day and has had five or fewer tardies during the year
4. **Highest Academic Award** - given at the end of the year to one student in each classroom who has the highest overall academic average for the class
5. **Valedictorian and Salutatorian Awards** - given to the two graduating seniors with the highest and second highest GPA's accumulated during four years of high school (These awards are subject to meeting minimum GPA and class size requirements.)

## **BOOK POLICY**

Textbooks are to be handled with care. Students will be expected to pay for excessive damage to textbooks. Please note that the annual book fee does not cover the total cost of the student's books each year. In an effort to keep costs more affordable, textbooks may be kept at the school and reused.

## **CELL PHONES**

1. Cell phones brought to school should be powered off and kept in the student's backpack or locker. Cell phones are not to be used during school hours and may be confiscated if found to be in use.

2. If a parent must contact a student due to an emergency during school hours, he must contact the school office.

## **CHURCH ATTENDANCE**

At Victory Christian Academy, we believe that church is a necessary and beneficial part of life. All students and their families are encouraged to attend weekly church services.

## **COMMUNICATION**

Open communication between parents and teachers is an integral ingredient for a successful school year. Parents are encouraged to communicate with teachers by e-mail, through the school software system, by writing a note, or by contacting the school office. Since it is not always possible to respond before school is out that day, it would be helpful to leave a phone number and the best time of day to be reached. In consideration of your child's teacher, please do not:

- Address school concerns at church.
- Meet during drop-off or pick-up times.
- Text after 8:00 P.M.

Grades, announcements, and communications will be sent through the school software system on a regular basis to inform parents of upcoming events and activities. This system will be used to track all aspects, including school calendar changes, athletic schedules, special awards, financial information, and other pertinent information.

Conferences may be requested during planning periods or after school. For your child's benefit, stay positive with your child concerning all staff members. Please remember that it is never appropriate to discuss any problem with other parents. Take the problem directly to those in charge of the situation. Any negative

social media posts about the school or the school staff will result in the removal of your child from the school.

### **EMERGENCY CLOSING**

For initial closings due to inclement weather, VCA makes the decision based upon a number of factors. The final decision whether or not it is safe for students to attend school ultimately lies with the parent. The administration will decide when school is open, parents must decide if it is safe for traveling to school. VCA cannot accept responsibility for determining if individual travel conditions are safe but will work with parents on a case-by-case basis.

Notifications will be sent out if there is a school closing including an e-mail, a phone call, and an announcement on WRAL.

### **HAIR AND DRESS CODE**

The purpose of the VCA dress code is to set a standard for all school activities. Our dress code is based on the following Biblical principles: modesty, appropriateness, and not identifying with any aspect of society contrary to God's Word. We believe that students should do their best to glorify God in every area of their lives, including their dress. Items worn should follow the student uniform policy. Parents have the ultimate responsibility to send their child to school with the correct dress and grooming.

1. The administration reserves the right to ask a student to change clothing or accessories if an item is not in keeping with the school uniform or dress code.
2. Clothing worn on campus or to a school event should not have messages, pictures, or symbols that do not reflect the philosophy of VCA.
3. Boys' hair is to be worn short, off the collar, off the ears, and not excessively full. They may not wear their hair in braids or a bun. Their hair should not be bleached, dyed, or highlighted.

They are to be clean-shaven with no facial hair. Girls in 7th through 12th grade may color or highlight their hair in a natural color.

4. If an undershirt is worn with a uniform shirt, it must match the school colors, and it must remain tucked. Leggings worn underneath uniform skirts are permitted in black.
5. Hemlines for girls' jumpers and skirts are to be knee-length or longer.
6. Hats are not to be worn in the building.
7. Flip-flops, slides, sandals, and crocs are not permitted. Students must wear a full shoe.
8. Tattoos and nontraditional body piercings are not permitted. Girls may wear tasteful (not excessive) jewelry, including earrings. Boys may not wear earrings or necklaces.
9. Uniforms may be purchased from the VCA online store at [www.frenchtoast.com](http://www.frenchtoast.com). Middle school and high school students enrolled in P.E. class must wear their school-issued P.E. shirt and black shorts. The shorts must be knee length and loose fitting. Students may purchase additional P.E. shirts from the school office.
  - Girls are to wear a collared polo shirt with the school logo paired with a skirt, or a collared polo shirt paired with a jumper.
  - Boys are to wear a collared polo shirt with the school logo paired with uniform pants. Boys in 4th–12th grade must wear a black or brown belt. Cargo pants are not permitted.
10. Hoodies or sweatshirts are not to be worn inside the classroom during school hours.
11. For special events such as high school banquets, boys are to wear dress shirts, ties, dress slacks, and dress shoes. Girls

are to wear modest, non-revealing dresses and dress shoes. Dresses must be approved by the school office at least one week before the event.

12. Students in first grade and above must wear their school uniform to all school functions, including but not limited to field trips, home and away school sporting events, and plays.

### ***ILLNESS/ACCIDENTS/MEDICATIONS***

1. First aid will be administered by the teacher or a staff member.
2. All medication must be kept in the office and accompanied by a written note giving parental permission and instructions on dosage and frequency.
3. If a student becomes sick or is involved in an accident at school, the parents will be notified promptly.
4. Students must be fever free (without the administering of fever reducing medications such as Tylenol or Ibuprofen) for 24 hours before returning to school.
5. For sicknesses such as strep and pink eye, the student must remain at home for 24 hours after the first dose of prescribed medicine before returning to school.
6. If a student contracts head lice, the student must be checked by office personnel and found to be nit free before returning to class.
7. Students must wait 24 hours before returning to school after vomiting. An underlying medical condition may waive this requirement with the administration's approval.

## **INSURANCE**

VCA provides student accident insurance, which serves as supplemental insurance. Medical expenses related to injuries are the responsibility of the parent. It is recommended that parents file with their primary insurance and the student accident insurance immediately after the incident. It is required for parents to carry family insurance on students participating in any of the sports programs.

## **LOCKERS**

The lockers are a convenience furnished by the school and may be subject to inspection at any time. Any student that defaces or misuses his locker may lose his privilege to use the locker.

- Pictures, posters, or other materials must be in keeping with the rules and philosophy of VCA.
- No student is to open another student's locker without permission.
- It will be the responsibility of the student to keep his locker neat, clean, and orderly at all times.
- No items are to be placed on top of the lockers.

## **LOST AND FOUND**

1. The school will not be responsible for the loss of any personal property. All articles of clothing and any personal possessions should be labeled with the student's name.
2. Anyone finding misplaced articles should turn them in to the office.
3. Unclaimed lost and found articles will be donated after thirty days.

## **MONEY**

When money is sent to school for fundraisers, book orders, field trips, lunches, etc., please enclose it in a sealed envelope with the following information on the front:

- Teacher's name and grade
- Student's name
- Amount
- Purpose

## **PARENT CHAPERONES AND VOLUNTEERS**

1. Parents are encouraged to volunteer at Victory Christian Academy. There are times throughout the school year when parents will be asked to serve as chaperones at school sponsored activities such as sporting events and field trips. When serving as chaperones, parents should observe the school dress code and abide by school policies.
2. Parent volunteers will be required to submit a volunteer application and submit to a background check.

## **PROMOTION AND RETENTION**

1. Retention is required for students in 1st through 8th grade failing any three subjects for the year.
2. High school students who fail a required course must repeat or complete a credit recovery course to earn credit.
3. High school promotion to the next grade is primarily dependent on the number of high school credits students have earned. Students will be promoted to the next grade if they have earned the required number of high school credits.

## ***SCHOOL OFFICE***

1. The school office hours are from 8:00 A.M. to 3:15 P.M. Monday through Friday.
2. All visitors to the school must check in at the office and receive a visitor's pass that must be worn while in the school buildings. Items such as lunches, homework, etc. may be left in the school office and will be delivered to the appropriate classroom.

## ***SEARCHES***

Lockers and desks are property of the school and may be searched at any time. Victory Christian Academy reserves the right to search students' belongings, including but not limited to backpacks, purses, and bags, provided reasonable suspicion for an investigation exists.

## ***SOLICITATION AND DISTRIBUTION***

Students and parents are not to distribute or sell items on campus without the permission of the administration.

## ***STUDENT AUTOMOBILES***

1. Students are not permitted to leave the school grounds until school is dismissed for the day except with administrative and parental permission.
2. Driving privileges may be revoked for the following reasons:
  - Allowing an unauthorized student to drive your car without parental permission
  - Driving recklessly
  - Transporting unauthorized students

- Leaving campus without permission
3. Students may not ride in private cars of other high school students going to or from school unless both sets of parents give permission. Students in the same family are exempt from this policy.
  4. Upon arriving at school, all students must report immediately to their designated areas rather than staying in their cars.
  5. Student drivers are to park in a designated parking area. Vehicles are not to occupy more than one parking space.
  6. Students under age 18 wishing to obtain a North Carolina driver's license or permit must first obtain a Driver's Eligibility Certificate from the school within 30 days of the date the student applies for his/her license or permit. In order for a student to receive a Driver's Eligibility Certificate, he or she must be making satisfactory progress toward graduation.

## **WEAPONS**

Weapons are not allowed on campus with the exception of authorized school officials or law enforcement officers.

# CONDUCT AND DISCIPLINE

---

## ***RULES OF CONDUCT AND DISCIPLINE***

### **1. GENERAL**

- A. The school expects the cooperation of students and parents in compliance and enforcement of the rules and regulations. The rules at Victory Christian Academy exist to promote the effective operation of the school and to ensure the safety of our students and teachers.
- B. Involvement in or speaking of involvement in criminal activity, immorality, pornography, homosexuality, illegal drug abuse, alcohol consumption, smoking, and other behaviors not in keeping with biblical values and the philosophy of VCA are strictly prohibited. Violation of these rules on or off campus may result in suspension or expulsion.
- C. Guns, knives, explosives, or weapons of any kind are strictly prohibited.
- D. Fighting, bullying, lying, stealing, cheating, cursing, and vulgarity are considered serious offenses and will be strictly disciplined.
- E. Official permission must be obtained to make or post video or audio recordings of school personnel.
- F. Any reference to the school must be made in a respectful manner.



- G. The school name, seal, emblem, or logo may not be reproduced on personal materials without official approval from the administration.
- H. The school will not be held responsible for any party or social function that is not officially approved or sponsored by the school.
- I. For all school sponsored functions, rules and regulations apply to both students and their guests.
- J. Any student who defaces or destroys property, even through negligence, must pay for the replacement or repair of the property and face appropriate disciplinary action.
- K. Students are expected to be respectful. Teachers, administrators, and staff members should not be addressed by their first name or last name alone.
- L. Proper Christian conduct with the opposite gender is emphasized in the school. The holding of hands, embracing, or other inappropriate physical conduct between those of the opposite gender or same gender will not be tolerated on campus, on the buses, or at any school activity. This conduct also apply to field trips, sporting events—at home or away—school programs, or any activity associated with VCA.
- M. The administration will not complete referral requests to attend proms or student dances from other schools.

## **2. CHAPEL**

- A. All students are required to attend chapels.
- B. Students should always bring their Bibles and participate in the service.

### **3. CLASSROOM**

- A. Students are to be in their seats before class begins.
- B. Students are not to leave their desks without the teacher's permission.
- C. Students are expected to come to class with the necessary supplies.
- D. Students are not to throw things in the classroom.
- E. Students should not sit at or touch items on the teacher's desk.

### **4. HALLS**

- A. Students are to walk quietly in the halls—absolutely no running or rough play is permitted.
- B. Students are to keep their hands and feet off of the walls.
- C. Students in the hall or outside of class during class time must have permission.

### **5. RESTROOMS**

- A. Students are not to loiter, talk loudly, or play in the restroom.
- B. Students must obtain permission from a teacher to use the restroom during class time.

## ***DISCIPLINE***

Victory Christian Academy has a commitment to and love for the students and families we serve. Students who follow a pattern of acceptable behavior enable us to accomplish academic excellence in a more effective manner. Our discipline system is designed for students who have habitual misbehavior. VCA reserves the right to

reasonably discipline students that fail to comply with any of the rules and regulations of the school, or that engage in any other behavior that is not in keeping with the philosophy of the school. Various forms of discipline will be administered depending upon the nature of the offense, the frequency of the commission, and the attitude of the student. Decisions regarding consequences such as probation, suspension, and expulsion are the exclusive authority of the administration. When problems arise, any of the following means of discipline may be used, though not necessarily in the order listed.

### **ELEMENTARY**

- The teacher will explain why the behavior is not acceptable, and privileges may be restricted (i.e., suspension from a class activity, shortened recess, or isolation in the classroom).
- A phone call or letter may be made to the parents.
- Extra work may be assigned.
- A student may be sent for a conference with the administrator.
- A student may receive an after-school detention (4th grade and above).

### **MIDDLE/HIGH SCHOOL**

Our discipline system follows three levels of behavior monitoring.

- **Level 1** categories include the following: tardiness, talking without permission, lack of classroom materials/participation, failure to follow instructions, dress code violation, and littering.

- **Level 2** categories include the following: direct disobedience, disrespect, inappropriate language, bullying, class disruptions, eating candy/gum/food without permission, chapel misconduct, phone usage during school hours, etc.
- **Level 3** categories include harassment, disrespect, stealing, profanity, skipping class, cheating, lying, etc.

The ultimate consequence is expulsion, which is determined by the administration. VCA has a responsibility to notify law enforcement in cases of illegal activity or actions.

### **DEMERIT SYSTEM**

Below are the general guidelines for demerits, but situations will be evaluated on a case-by-case basis.

<b>Offense</b>	<b>Penalty</b>
Level 1 categories	1 demerit
Level 2 categories	5 demerits
Level 3 categories	10 demerits

<b>Demerit Limit</b>	<b>Penalty</b>
10 demerits	1st after-school detention
20 demerits	2nd after-school detention
30 demerits	out-of-school suspension
40 demerits	3-day out-of-school suspension
50 demerits*	expulsion

\*At 50 demerits, students may submit a written request to the administration for an additional extension of 5 demerits.

Demerits are reset each semester.

## **DISCIPLINARY STEPS**

### **PARENT/STUDENT CONFERENCE**

The student and his parents may be required to meet with administration concerning the student's conduct according to the discipline system. A behavior contract will be planned with defined measurable goals for improved conduct.

### **AFTER-SCHOOL DETENTION**

Students serve detention after school on designated days for 35 minutes in length. Parents will be notified prior to the detention. During detention, students may not talk. Students may be assigned work/clean up duties on campus. Failure to serve assigned detention when scheduled will result in an additional detention.

1. Detentions will be assigned for inappropriate behavior as deemed necessary.
2. Detention is served after school from 3:05 P.M. to 3:40 P.M. Students who are late or leave early will forfeit that detention and must participate at a later date.
3. Students failing to serve detention may result in the student's suspension.
4. Detentions are rescheduled only under special circumstances approved by the administrator.

### **OUT-OF-SCHOOL SUSPENSION**

Serious discipline problems may result in students being assigned an out-of-school suspension. Students are not allowed to be on campus for any reason without permission from the administration and may not attend any student function during the suspension

period. Students may receive half credit for work completed during an out-of-school suspension.

## **HIGH SCHOOL COURSES**

---

### ***GRADUATION REQUIREMENTS***

Upon the completion of the minimum prescribed course of study, the student is awarded a high school diploma. Since the graduation ceremony is a privilege and not a right, which follows the completion of academic requirements, participation is granted to each student who is in good standing. Any action, activity, and/or event not in keeping with the philosophy of VCA which follows the completion of academic studies and precedes the event of graduation can cause the privilege of the ceremony to be revoked. All credits necessary for graduation must be completed before a student will be permitted to march in the graduation exercises. VCA cannot be responsible for the inconvenience caused by a senior who fails courses during the last days of school. All financial accounts must be paid in full for seniors to participate in graduation.

1. A minimum of 22 credits including required classes is needed for graduation. Subjects taken and passed in other schools will be counted toward graduation at VCA.
